## HOT TOPICS – AUGUST 2022 INTERNATIONAL DAY COMMEMORATING THE VICTIMS OF ACTS OF VIOLENCE BASED ON RELIGION OR BELIEF

BACKGROUND: This important day came about as the result of the 2019 General Assembly of the United Nations resolution 73/296, which designated August 22<sup>nd</sup> as the international day to commemorate the victims of acts of violence based on religion or belief. It reports that since that designation "the world has faced an alarming escalation of hate, both online and offline, targeting religion or belief minorities as well as members of lesbian, gay, transexual and intersex communities" [Source: International Day Commemorating the Victims of Acts of Violence Based on Religion or Belief, 22 August 2021 | OHCHR]

WHY IS THIS IMPORTANT?: As stated above, according to the United Nations (UN), acts of



intolerance and violence, which are based on religion and belief against individuals "including against persons belonging to religious communities and religious minorities around the world, and the number and intensity of such

incidents, which are often of a criminal nature and may have international characteristics, are increasing" [Source: International Day Commemorating the Victims of Acts of Violence Based on Religion or Belief | United Nations]

So, **August 22<sup>nd</sup>** is the day chosen to commemorate this important issue because it recognised the importance of giving both support and assistance to victims of acts of violence based upon religion or belief as well as members of their families.

Below is a table of the Articles and protocols covered by the Act – which ones do you think may impact your decision making?

## **HUMAN RIGHTS ACT 1998**

What human rights are covered by the Act?

The Act sets out your human rights in a series of 'Articles'. Each Article deals with a different right. These are all taken from the ECHR and are commonly known as 'the Convention Rights':

Article 2: Right to life

Article 3: Freedom from torture and inhuman or degrading treatment

Article 4: Freedom from slavery and forced labour

Article 5: Right to liberty and security

Article 6: Right to a fair trial

Article 7: No punishment without law

Article 8: Respect for your private and family life, home and correspondence

Article 9: Freedom of thought, belief and religion

Article 10: Freedom of expression

Article 11: Freedom of assembly and association

Article 12: Right to marry and start a family

Article 14: Protection from discrimination in respect of these rights and freedoms

Protocol 1, Article 1: Right to peaceful enjoyment of your property

Protocol 1, Article 2: Right to education

Protocol 1, Article 3: Right to participate in free elections

Protocol 13, Article 1: Abolition of the death penalty
